


Minutes of the meeting held on 13/03/2020 at 12 noon in the conference hall of the DC's Office, Lakhimpur in connection with expediting the works of Axom Adarxo Gram Yojana (AAGY) scheme.

Members Present: - Annexure "A".

The meeting was chaired by the District Development Commissioner, Lakhimpur. At the outset the District Development Commissioner, Lakhimpur gave the introductory speech and explained the meeting agenda and guidelines of Axom Adarxo Gram Yojana (AAGY) scheme. After threadbare discussion, the following decisions are taken:

1. The District Development Commissioner, Lakhimpur instructed the Circle Officer, Nowboicha Revenue Circle to re-constitute the Village Level Convergence Committee as per guidelines of Axom Adarxo Gram Yojana (AAGY) scheme and submit the same to the office of the undersigned within 3 days. **[Action: CO, Nowboicha Rev. Circle]**
2. The District Development Commissioner, Lakhimpur instructed the Circle Officer, Dhakuakhana Rev. Circle to constitute the Village Level Convergence Committee as per Guidelines of Axom Adarxo Gram Yojana (AAGY) scheme and submit the same to the office of the undersigned within 3 days. **[Action: CO, Dhakuakhana Rev. Circle]**
3. The District Development Commissioner, Lakhimpur instructed all concerned Members to start the Survey Template for Household Level Survey (Annexure II) and Survey Template for Village Level Survey (Annexure III) as given in the Guidelines of Axom Adarxo Gram Yojana (AAGY) scheme and submit within a week. **[Action: All Concerned Members]**
4. The District Development Commissioner, Lakhimpur informed that a detailed discussion regarding the implementation of the Axom Adarxo Gram Yojana (AAGY) scheme shall be carried out in subsequent period.

Minutes of the meeting held in connection with the implementation of the "Axom Adarxo Gram Yojana" scheme on 21.09.2020 at 3:00 p.m. in the conference hall of the office of the Deputy Commissioner, Lakhimpur.

Members Present: - Annexure "A".

The meeting was chaired by Dr. Jeevan B., IAS, Deputy Commissioner, Lakhimpur. At the outset, the Deputy Commissioner, Lakhimpur gave the introductory speech and requested the District Development Commissioner, Lakhimpur, to start the PowerPoint presentation on "Axom Adarxo Gram Yojana" scheme. After completion of the presentation, the following discussions were initiated:

1. The Deputy Commissioner, Lakhimpur stated that according to the guidelines of "Axom Adarxo Gram Yojana" scheme, the villages covered under Sansad Adarsh Gram Yojana shall be excluded from the said scheme. Since, Bochagaon village has been selected both for Pradhan Mantri Adarsh Gram Yojana (PMAGY) and Axom Adarxo Gram Yojana scheme, the meeting unanimously decided that Bochagaon village will continue in "Axom Adarxo Gram Yojana" scheme too.
2. The Deputy Commissioner, Lakhimpur instructed the Circle Officers of concerned revenue villages to constitute and notify the Village Level Committee in consultation with the Hon'ble MLAs of concerned villages. **[Action: Circle Officer, North Lakhimpur, Dhakuakhana, Nowboicha and Bihpuria Revenue Circle]**
3. The Deputy Commissioner, Lakhimpur instructed the Senior Planning Officer, Lakhimpur to prepare the schedule for conducting Participatory Rural Appraisal for the said scheme deputing one ADC along with Hon'ble MLAs of concerned villages. **[Action: Senior Planning Officer, DC's office, Lakhimpur]**
4. The DC, Lakhimpur directed the Circle Officers and BDO of concerned villages to conduct Participatory Rural Appraisal for the said scheme. Accordingly, the BDO of concerned villages shall designate a team on that particular date for the same. The Circle Officers of the concerned villages shall assist the BDOs in identifying the place having basic amenities like *pucca* flooring for conducting Participatory Rural Appraisal. **[Action: All concerned COs and BDOs]**
5. The DC, Lakhimpur also instructed the Circle Officers to ensure participation of women SHGs, local senior citizens and prominent persons of the village in order to conduct village-mapping and also identify in the form of a SWOT analysis of the concerned village. In this regard, the Deputy Commissioner, Lakhimpur also directed to depute the Senior Officers of their concerned department for the Participatory Rural Appraisal programme. **[Action: All concerned Circle Officers]**
6. The DC, Lakhimpur directed the BDOs of concerned villages to bring along with them the Gram Panchayat Development Plan (GPDP) of 2018 in the Participatory Rural Appraisal programme. **[Action: All concerned BDOs]**
7. The DC, Lakhimpur urged all concerned Departments for saturation of all the schemes implemented in the selected villages for which a baseline survey has to be conducted at Household and Village Level as per survey template I & II provided in the "Axom Adarxo Gram Yojana" guidelines. **[Action: All concerned Departments]**
8. The DC, Lakhimpur directed the Agriculture, Veterinary, Fishery, Sericulture and Handloom & Textile Department to identify all potential livelihood activities in the selected villages and also areas to be developed. **[Action: Agriculture, Veterinary, Fishery, Sericulture and Handloom & Textile Department]**
9. The DC, Lakhimpur directed all concerned Departments to depute Senior most officers from their concerned department to assess the gap-filling and areas for improvement, which is the VDP. Moreover, he also directed to start the infrastructure deficit and basic livelihood survey immediately after the Participatory Rural Appraisal programme. **[Action: All concerned Departments]**

Minutes of the meeting held in connection with Quarterly review of Axom Adarxo Gram Yojana (AAGY) scheme on 02/11/2021 in the office chamber of the District Development Commissioner, Lakhimpur at 02:00 P.M.

The Meeting was chaired by Sri Monuj Kumar Boruah, District Development Commissioner, Lakhimpur. At the outset, the District Development Commissioner, Lakhimpur welcomed all the members present in the meeting and initiated the discussion on monitoring and review of all the schemes implemented under Axom Adarxo Gram Yojana (AAGY) for the year 2018-19 in Lakhimpur District. After threadbare discussion, the following decisions were taken:

1. The District Development Commissioner, Lakhimpur, instructed all concerned Block Development Officers that, a physical progress of above 50% of all the schemes must be achieved within 15 days positively. [Action: All concerned BDOs]

2. The DDC, Lakhimpur directed all concerned Block Development Officers that all schemes implemented under Axom Adarxo Gram Yojana (AAGY) for the year 2018-19 must be completed within a month positively. [Action: All concerned BDOs]

3. The DDC, Lakhimpur directed all concerned Block Development Officers that proper documentation including photographs and videos of all the schemes implemented under Axom Adarxo Gram Yojana (AAGY) for the year 2018-19 must be done. [Action: All concerned BDOs]

4. The DDC, Lakhimpur stated that as per the Guidelines of Axom Adarxo Gram Yojana, in order to define the main elements of 'what encapsulates an Adarxo Gaon', the Sustainable Development Goals (SDGs) have been used to set forth certain targets and indications which are to be achieved for fulfilling the larger holistic development.

In this connection, he instructed all concerned Block Development Officers to organise various activities in the concerned villages like organisation of traditional sports amongst the village fellows, carrying out plantation programme in the village and generate awareness amongst them to make the village green and clean. [Action: All concerned BDOs]
