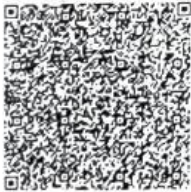

(1) That I was a contesting candidate at the general election/bye election to the House of the People / Legislative Assembly of Assam from 76 No Lakhimpur Parliamentary/Assembly constituency, the result of which was declared on 4th day of May, 2026.

2) That I/my election agent kept a separate and correct account of all expenditure incurred /authorised by me / my election agent in connection with the above election between 23/03/2026 to 04/05/2026 (the date on which I was nominated) and the date of declaration of the result thereof, both days inclusive.

(3) That the said account was maintained in the Register furnished by the Returning Officer for the purpose and the said Register itself is annexed hereto with the supporting vouchers/bills mentioned in the said account.
