In continuation of this Office Advertisement Dated 19/11/2025 and Addendum dated 06/01/2026, it is hereby notified for information to all concerned that the selection process for the post of Office Peon in the establishment of Chief Judicial Magistrate, Lakhimpur, North Lakhimpur, which was initially proposed to be conducted through Viva Voce only, has been revised.

Due to receipt of a large number of applications, it has been decided with the approval of the Selection Board, to conduct a Screening Test in MCQ (Multiple Choice Question) format of qualifying nature only, for short listing the candidates.

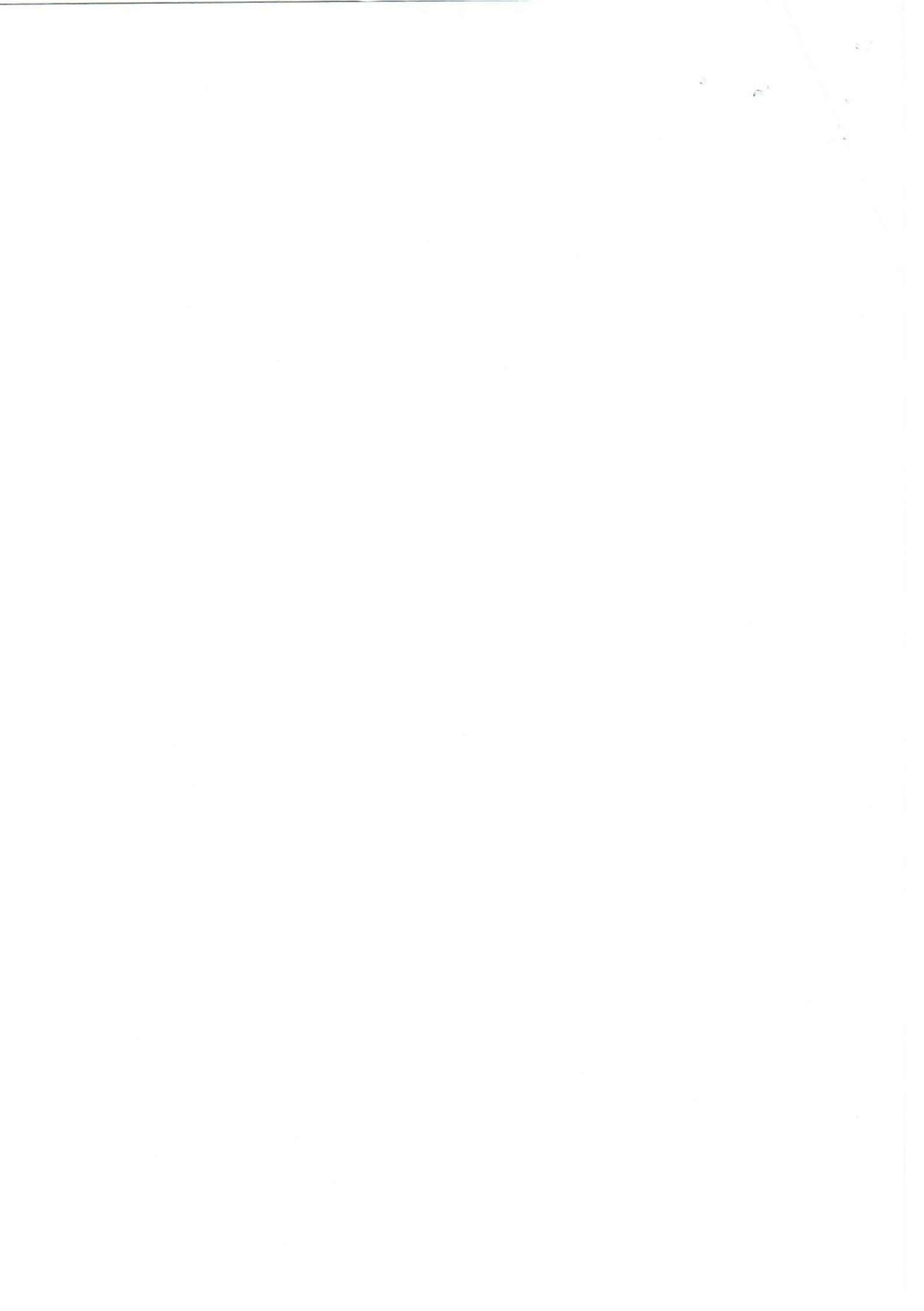

Screening test will carry 40 (forty) marks and will consist of MCQ type questions. Marks obtained therein will not be considered for preparation of the final merit list. Only those candidates who qualify in the Screening Test will be called for the Viva-Voce, the date of which will be notified in due course.

The question paper will be set in both English and Assamese languages, and



candidates may answer accordingly.

Important Instructions:

1. Candidates must report to the examination venue as per the scheduled time.
2. Candidates shall bring valid Photo Identity Proof (Aadhaar Card/Voter ID/PAN Card, etc)
3. Candidates must bring original documents along with two copies of recent passport size photographs.
4. **No separate call letters will be issued for the Screening Test.**
5. No TA/DA shall be admissible for appearing in the test.
6. Use of mobile phones or any other electronic gadgets is strictly prohibited during exam.
7. The qualifying marks of the screening test shall be decided by the selection board and its decision shall be final.






