

MINUTES OF PRE-BID MEETING FOR E-TENDER OF HANDLING & TRANSPORT CONTRACTOR OF PMGKAY RICE UNDER NFSA/13 FOR THE FINANCIAL YEAR 2026-2027 HELD ON 17/01/2026 AT 3.00 PM IN THE CONFERENCE HALL OF DISTRICT COMMISSIONER OFFICE, LAKHIMPUR.

The meeting was presided over by the District Commissioner, Lakhimpur.

The Chairman of the committee welcomed the committee members and intended bidders present and informed the members that the meeting is convened for discussion on pre-bid queries related to the NIT dtd 13/01/2026 being floated through the portal <https://assamtenders.gov.in> for selection and appointment of "**Handling and Transport Contractor and Fixation of Rate**" for transportation of food grains under NFSA-2013 in 2 (two) Tier System i.e. Tier -I (from FCI Godown to GPSS/ WCCS Godown) and Tier -II (from GPSS/ WCCS Godown to FPS Dealer/Agent) for Transportation and delivery up to F.P. Shop level in respect of Lakhimpur Sadar and Co-District Dhakuakhana of **Lakhimpur District for the financial year 2026-2027**. A threadbare discussion was conducted regarding the points mentioned below:

1. The Finance & Accounts Officer, D. C's Office, Lakhimpur narrated the NIT terms & conditions elaborately in the house specifically emphasizing on the amended clauses, and mentioned that No bidders shall submit bid with Zero rates in the BOQ. The bidders shall submit undertaking of tax compliance as mentioned in the annexures and valid FSSAI license etc.
2. The Joint Director & DIO, NIC Lakhimpur clarified the technical queries related to the NIT being floated for the FY 2026-2027.

The prospective bidders have individually notified the house that they comprehend all the terms of the NIT and that they hold no objections concerning the NIT as mentioned above.
